INFORMATION PURSUANT TO REG. EU 2016/679 (GDPR) "GENERAL DATA PROTECTION REGULATION"

Pursuant to the italian art. 13 D.Lgs. 30.6.2003 n. 196 (hereinafter "Codice Privacy") and in accordance with the European Regulation 2016/679 "General Data Protection Regulation" (hereinafter "GDPR"), we give you general information about the NDS Energy s.r.l. personal data (you provide) usage.

1. TREATMENT HOLDER

The data in charge is NDS Energy s.r.l., via G.Pascoli di Terrarossa (PE), Vat Number 02065080687 (hereinafter, "Holder").

2. TREATMENT SUBJECT

Subject of this processing are: personal and identification data (in particular, company name, company address, name, surname, social security number, VAT number, email, telephone number, bank details - later, "personal data" or even "data" ") Except the categories of data referred to the art. 9 par. 1 EU Reg. 2016/679. The data have been or will be communicated by you during the registration phase during employment relationships, contracts and other exchanges between you and the Holder.

3. TREATMENT PURPOSES

Your persona data will be processed as follow:

3. TREATMENT METHOD

Your personal data process will follow the operations indicated in art. 4 of the Codice Privacy and art. 4 n. 2) GDPR and more specifically: collection, registration, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and destruction of data. Your personal data are subjected to both paper and electronic and/or automated processing.

The data in charge will process personal data for the time necessary to fulfill the aforementioned purposes and in any case for no more than 10 years from the end of the relationship for the purposes of service and for no more than 4 years from the end of the relationship for Marketing Purposes.

The legitimate interests pursued by the data in charge in data processing is to respect and honor the contractual obligations signed between the parties. Pursuant to art. 6 the lawfulness of the processing is based on the express consent of the interested subject, by in writing document.

4. DATA ACCESS

Your data will be accessible, for the purposes pursuant to the art. 3.A) e 3.B), to: employees and collaborators of the data in charge or the collaborating companies of NDS Energy s.r.l., in their capacity as persons in charge and/or internal managers of the processing and/or system administrators;

to partner companies of NDS Energy s.r.l. of which the holder is a part (for example, for support activities in the study of the feasibility of the client's project, for technical project management activities, for the storage of personal data, etc..) or for third parties (for example, provider for the management and maintenance of the website, suppliers, lenders, professional offices, etc..) that carry out outsourcing activities on behalf of the holder, in their capacity as external processors.

5. DATA SHARING

The data in charge. without your express consent (pursuant to the art. 24 lett. a), b), d) Codice Privacy e art. 6 lett. b) e c) GDPR), can share your data for the purposes referred to in art. 2.A) to: Supervisory Organ, Judicial Authorities and to all the other subjects to whom the data sharing is mandatory by law for the accomplishment of said purposes. Your information will not be disseminated, in no other ways.

6. DATA TRANSFER

The management and storage of personal data will be stored out on servers located within the European Union of the holder and/or third-party companies appointed and duly appointed as Data in charge. The data will not be transferred out of the European Union. In any case. The Data in charge, if necessary, is licensed to move the server location to Italy and/or the European Union and/or non-EU countries. In this case, the Data in charge, hereby ensures that the transfer of non-EU data will take place in accordance with the applicable legal provisions, stipulating, if necessary, agreements that guarantee an effective protection level and/or adopting the standard contractual clauses provided for European Commission.

7. NATURE OF PROVIDING DATA AND CONSEQUENCES OF REFUSING TO ANSWER

The data gathering for the purposes referred to in art. 3.A) is compulsory. Without this process, we can not guarantee neither the registration to the site nor the services of the art. 3.A).

The data gathering for the purposes referred to in art. 3.B) is optional. Therefore you can decide not to give any data or to subsequently deny the possibility of processing data already provided: in this case, you will not receive newsletters, commercial communications and advertising material relating to the Services offered by the Data Controller. In any case, you will continue to be entitled to the Services referred to in art. 3.A).

8. DATA SUBJECTS RIGHTS

As data subjects, you have the rights referred to the art. 7 of the Codice Privacy and art. 15 of the GDPR and precisely the rights of:

obtain confirmation, of the existence or not, of personal data concerning you, even if not yet registered, and their communication

in an intelligible form;

obtain indication about: a) origin of personal data; b) purposes and methods of processing; c) the method applied in case of treatment carried out with the aid of electronic instruments; d) identification details of the holder, the managers and the representative pursuant to art. 5, paragraph 2 of the Codice Privacy and art. 3, paragraph 1 of the GDPR; e) the subjects or categories of subjects to whom the personal data may be shared with or who may become aware of it in their capacity as representative in it! territory of the State, of managers or agents;

III. obtain: a) updating, rectification or, when necessary, data integration; b) the erasure, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed; c) the certification that the operations referred to in letters a) and b) have been brought to

the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except in the
